I am directed to state that as per direction of the ECI the Summary Revision of Electoral Roll w.r.t. 01.01.2021 as qualifying date is scheduled from 16.11.2020 to 15.12.2020, revision of electoral rolls with reference to 1<sup>st</sup> January of the coming year as the qualifying date. The primary objective of the Special Summary Revision – 2021 is to include newly eligible voters, young voters who have completed or will be completing age of 18 on or before date 01.01.2021. Another objective for the Special Summary Revision-2021 is to give opportunities for correction in electors' particulars and also to invite objections against any wrong inclusion in the Electoral Roll.

As in the present scenario due to COVID Pandemic, most of the colleges/institutes are holding online classes.

It is, therefore, requested that colleges/Institutes may be instructed to show the attached SSR Creatives for public awareness, to students during their online classes (atleast once in a week) so that maximum eligible young voters get enrolled. They may be motivated to get themselves registered as voter and also to pass on the message to their family members/near-dear ones and friends.
